SECTION I: INSTRUCTIONS TO BIDDERS

1. Rights of Public Entity

The **Ministry of Industries, Mines and Energy** reserves the right:

- (a) to split the contract as per the lowest evaluated cost per lot; and
- (b) to accept or reject any quotation or to cancel the quotation process and reject all quotations at any time prior to contract award.

2. Preparation of Quotations

You are requested to quote for the works mentioned in Section III, by completing, signing and returning:

- (a) the Quotation Letter in Section II with its annex for Bid Securing Declaration, where applicable;
- (b) the Priced Activity Schedule in Section IV;
- (c) the Specifications and Compliance Sheet in Section V; and
- (d) any other attachment as deemed appropriate

You are advised to carefully read the complete Request for Quotations document, including the Special Conditions of Contract in Section VII, before preparing your Quotation. The standard forms in this document may be retyped for completion but the Bidder is responsible for their accurate reproduction.

3. Validity of Quotations

The quotation validity period shall be **60 days** from the date of bid submission deadline.

4. Eligibility Criteria

To be eligible to participate in this Quotation exercise, you should:

- (a) have a **valid certified** company Registration Certificate; **(certified by Namibian police)**.
- (b) have an original valid good Standing Tax Certificate; **(certified by Namibian police)**.
- (c) have an original valid good Standing Social Security Certificate. **(certified by Namibian police)**.
- (d) have a valid certified copy of Affirmative Action Compliance Certificate, proof from Employment Equity Commissioner that bidder is not a relevant employer, or exemption issued in terms of Section 42 of the Affirmative Action Act, 1998; **(certified by Namibian police)**.
- (e) Complete and sign attached Bid Securing declaration.
- (f) An undertaking on the part of the Bidder that the salaries and wages payable to its personnel in respect of this proposal are compliant to the relevant laws, Remuneration Order, and Award, where applicable and

that it will abide to sub-clause 4.6 of the General conditions of Contract if it is awarded the contract or part thereof;

(g) Proof that Air Conditioning Services are part of the bidder's core business principle (It must be on the founding statement).

(h) Company Experience: At least 3 years' proven experience in air conditioning installation and servicing. *(Please provide Reference Letters / Completion Certificates from at least 3 clients (government or State-Owned Enterprises). It must clearly state the type of work (installation/servicing of AC units), duration, and whether the work was successfully completed. The Ministry shall verify the authenticity of the Letters.*

(i) Qualified Personnel: Attach CVs of two qualified AC technicians with minimum NTA Level 3 Certificate in AC/refrigeration certificate or equivalent.

(j) Attach a CV of one qualified Electrical technician with minimum NTA Level 3 Certificate in Electrical General. For bidders who will bid for Windhoek, the Electrician must be certified by the city of Windhoek and have a valid wireman license.

(k) Attach credit worthiness from material supplier or credit facilities letter from the commercial bank or DBN. The letter issued should indicate this bid reference number and maximum credit to be availed to the bidders.

Failure to attach letters with bid reference number will lead to automatic disqualification.

Only bidders who have access to credit facilities of at least N\$500 000.00 will be considered.

(l) Complete the whole bidding document where required and Incomplete bidding document shall lead to disqualification.

(m) All pages of the bidding documents should be initialled.

5. Bid Securing Declaration

Bidders are required to submit a Bid Securing Declaration for this procurement process.

6. Works Completion Period

The completion period for works shall be **36 months** after acceptance and issue of an award letter. Successful bidders will enter into a service level agreement with the ministry for the duration of 36 months

7. Sealing and Marking of Quotations

Quotations should be sealed in a single envelope, clearly marked with the Procurement Reference Number, addressed to the Public Entity with the Bidder's name at the back of the envelope.

8. Submission of Quotations

Quotations should be deposited in the Quotation/Bid Box located at 6 Aviation Road, Ground Floor, Block F1, not later **30 January 2026 at 10h00**. Quotations by post or hand delivered should reach 6 Aviation Road by the same date and time at latest. Late quotations will be rejected.

Quotations received by e-mail will not be considered.

9. Opening of Quotations

Quotations will be opened internally by the Public Entity immediately after the closing time referred to in section 8 above. A record of the Quotation Opening stating the name of the bidders, the amount quoted, the presence or absence of a Bid Security/Bid Securing Declaration, will be posted on the website of the Public Entity and available to any bidder on request within three working days of the Opening.

10. Evaluation of Quotations

The Public Entity shall have the right to request for clarifications in writing during evaluation. Offers that are substantially responsive shall be compared on the basis of evaluated cost, subject to Margin of Preference where applicable, to determine the lowest evaluated quotation.

11. Technical Compliance

The Specifications and Compliance Sheet details the minimum specifications of the works to be carried out. The specifications have to be met, but no credit will be given for exceeding the specifications.

12. Prices and Currency of Payment

Prices for the execution of works shall be fixed in Namibian Dollars as quoted.

Quotations shall cover all costs of labour, materials, equipment, overheads, profits and all associated costs for performing the works, and shall include all duties. The whole cost of performing the works shall be included in the items stated, and the cost of any incidental works shall be deemed to be included in the prices quoted.

13. Margin of Preference

13.1. The applicable margins of preference and their application methodology are as follows:

The Margin of Preference is applicable to this request for this Bid is: **Preference will only be granted to bidders as per Government notice No.13 in terms of the code of good practice issued on 31 January 2023 in terms of section 71 and 72 of the Public Procurement Act, 2015 and Public Procurement Act, 2015 as amended.** The
