

#### INTRODUCTION

The petroleum acts and regulations serve as instruments by which the Ministry of Mines and Energy regulates the Namibian petroleum sector. In order to ensure an effective and efficient legislative framework for the petroleum industry, there exist a need to review and update the petroleum acts, regulations and Petroleum Agreement. Therefore, the Ministry of Mines and Energy is seeking the service of a competent consultant with the necessary skills and experience to comprehensively review and update the current petroleum legislation.

#### **SCOPE OF WORK**

Under the auspices of the Ministry of Mines and Energy and the Oceans and Natural Resources Advisory Division (ONR) – Commonwealth, the consultant will be required to:

- Review and analyse the ONR Advisory Report concerning the Namibian Petroleum Sector: considering the legislative, regulatory and fiscal arrangements for the management of upstream petroleum operations in Namibia;
- Review and analyse the ONR Advisory Report Concerning Local Content in the Namibian Petroleum Sector: concerning the development and implementation of a local content programme for Namibia's petroleum sector;
- Review and benchmark current petroleum Agreement, petroleum laws (upstream & downstream) and penalties to international best practises with a view to identify any shortcomings and challenges that hampers the effective implementation of Government plans and programmes;
- Prepare draft laws and regulations subject to ONR drafting instructions, for the amendment of specific sections and paragraphs or revised drafts of entire (upstream & downstream) legislation and Petroleum Agreement with explanatory memorandum highlighting changes proposed;
- Review draft NAMCOR Bill;

- Arrange and conduct workshops and consultations with all stakeholders;
- Provide detailed work plans that includes, monthly monitoring and evaluation reports of the scope of work.
