SECTION I: INSTRUCTIONS TO BIDDERS

1. Rights of Public Entity

The **Ministry of Mines and Energy** reserves the right:

- (a) to split the contract as per the lowest evaluated cost per site, or
- (b) to accept or reject any quotation or to cancel the quotation process;
and
- (c) reject all quotations at any time prior to contract award.

2. Preparation of Quotations

You are requested to quote for the services mentioned in Section III, by completing, signing and returning:

- (a) the Quotation Letter in Section II with its annex for Bid Securing Declaration, where applicable;
- (b) the Priced Activity Schedule in Section IV;
- (c) the Specifications and Performance Standards in Section V; and
- (d) any other attachment as deemed appropriate.

You are advised to carefully read the complete Request for Quotations document, including the Contract Data Sheet in Section VII, before preparing your quotation. The standard forms in this document may be retyped for completion but the Bidder is responsible for their accurate reproduction.

3. Validity of Quotations

The quotation validity period shall be for **30 days** from the date of submission deadline.

4. Eligibility Criteria

To be eligible to participate in this Quotation exercise, you should:

- a) have a **valid** company Registration Certificate;
- b) have an **original/certified copy** of a valid good Standing Tax Certificate;
- c) have an **original/certified copy** of a valid good Standing Social Security Certificate;
- d) have a **valid certified copy** of Affirmative Action Compliance Certificate, proof from Employment Equity Commissioner that bidder is not a relevant employer, or exemption issued in terms of Section 42 of the Affirmative Action Act, 1998; Complete and sign the attached **Bid-securing Declaration**.
- e) Complete and sign an **undertaking on the part of the Bidder** that the salaries and wages payable to its personnel in respect of this proposal

are compliant to the relevant laws, Remuneration Order, and Award, where applicable and that it will abide to sub-clause 4.6 of the General conditions of Contract if it is awarded the contract or part thereof;

- f) Provide Instrumentation Certificate or related qualification for lead technician
- g) All pages of the bidding documents should be initialled where possible.
- h) No correctional fluid allowed.

5. Delivery

Delivery shall be 5 days after acceptance/issue of Purchase Order. Deviation in delivery period *shall not be accepted*

6. Sealing and Marking of Quotations

Quotations should be sealed in a single envelope, clearly marked with the Procurement Reference Number, addressed to the Public Entity with the Bidder's name and contact information at the back of the envelope.

7. Submission of Quotations

Quotations should be deposited in the Quotation/Bid Box located at 6 Aviation Road, Ground Floor, Block F1; Office F1 005 not later than **5 August 2022 at 10h00**. Quotations by post or hand delivered should reach 6 Aviation Road by the same date and time at latest. Late quotations will be rejected.

Quotations received by e-mail will not be considered.

8. Opening of Quotations

Quotations will be opened internally by the Public Entity immediately after the closing time referred to in instruction 8 above. A record of the Quotation Opening stating the name of the bidders, the amount quoted, the presence or absence of a Bid Security/Bid Securing Declaration, will be provided on Bidder's request within three working days of the Opening.

9. Evaluation of Quotations

The Public Entity shall have the right to request for clarifications in writing during evaluation. Offers that are substantially responsive shall be compared on the basis of labour cost and call-out fees, subject to Margin of Preference where applicable, to determine the lowest evaluated quotation.

10. Technical Compliance

Bidders shall submit along with their quotations documents, catalogues and any other literature to substantiate compliance with the required specifications and to qualify deviations if any with respect to Public Entity's requirements.

The Specifications, Performance Requirements and Compliance Sheet details the minimum specifications of the goods/items to be supplied. The specifications have to be met but no credit will be given for exceeding the specifications.

11. Prices and Currency of Payment

Prices shall be fixed in Namibia Dollars.

12. Margin of Preference

The Ministry of Mines and Energy Laboratory seek to outsource all Laboratory Maintenance and Repair of Geo-Lab Instruments and Scientific Equipment to certified, experienced and qualified service providers. The Service Provider shall perform and/or facilitate the maintenance of all lab instruments and equipment, which include;

- ✓ Draw up a service maintenance schedule for each equipment for the three (3) year renewable contract duration.
- ✓ Digital Remote Support, diagnostic, and corrective services
- ✓ Manage any available warranties
- ✓ Preventative Maintenance Services

- ✓ Calibration Programme for Metrology Instruments
- ✓ Emergency Services
- ✓ Parts Procurement and Replacement (Preventative Service Maintenance kit and corrective maintenance parts), full covering on spare parts that might be required
- ✓ Software and firmware updates, upon request
- ✓ Facilitate Maintenance work where necessary
- ✓ Contact details for the service provider should be provided in the resulting contract: Physical address, Telephones, emails and any additional contact details may there be any.
- ✓ Should be able to fully cover labour and travel expenditure when subcontracting.
- ✓ The actual work to be performed during maintenance service should be clearly stated
- ✓ Service provider should account for auxiliary equipment, such as; vacuum pumps used to change the pressure in a contained space to create a full or partial vacuum either mechanically or chemically e.g. LP50 and GTS1 Thin Section cut-off saw, and chillers for conventional instruments.
- ✓ The resulting maintenance service contract should give MME priority response in terms of onsite and offsite assistance.
- ✓ In case of emergency, response time must be within two (2) days and the turn-around time must be 2 weeks.
- ✓ The service provider with available technical support personnel for corrective and preventive maintenance within 24-48hours shall be required.
- ✓ Warranties if any should be clearly stated.
- ✓ Prices and currency of payment – Prices for the execution of work (General preventative maintenance including service maintenance kit) shall be quoted fixed and firm in Namibia Dollars, and will not be subjected to revision or variation, if awarded the contract prior to the expiring date of the quotation validity.
- ✓ Terms of Payment - Payments by the Employer (Ministry of Mines and Energy) shall be made to the Supplier upon completion of service requested, and be paid within 30 days of receipt of an invoice.
- ✓ Termination of agreement conditions terms should also be clearly stated.
- ✓ The Service provider shall provide corrective and preventative maintenance training for End-Users while performing the service.
- ✓ Site visit before bidding is mandatory.
- ✓ Service provider business activities/company profile should be in line with the work requested.
- ✓ **Should one of the contracted suppliers fails to deliver as per the agreement, the other contracted supplier should be able to step in and provide the service or facilitate the acquisition of such service.**
