Appointment Requirements: An appropriate 4 Year Bachelor Degree (or equivalent qualification) in Natural Resources Management, Petroleum Engineering, Law, Occupational Health and Safety, or any other petroleum related disciplines from a recognized tertiary institution, plus approximately 5 years of appropriate experience in the petroleum sector.

Additional Requirements:

Applicants should have thorough knowledge of the Petroleum Industry, its stakeholders, Policies and Laws. He/she should possess the ability and knowledge to carry out supervision, safety assessments and inspection verifications. He/she must possess excellent planning, analytical, organizational, oral and written communication skills. A Masters qualification in Petroleum, Management and/or Occupational Health and Safety related field will be an added advantage.

- Monitor the Marine Offloading Facility (Joint Bunkering Depot-note the total volume imported and exported monthly.
- Determine and ensure the monthly stock-holding at Walvis Bay Depots.
- Monitor the distribution of Diesel & Petrol in the country to ensure the correct rural subsidy for the deserving fuel distributors/wholesalers.
- Assisting with daily administrative tasks such as licensing application review and evaluation.
